Computer and Internet Acceptable Use Agreement

Please read this document carefully before signing.

Internet access is now available to students and employees in the Keystone Education Center Charter School. We are very pleased to bring this access to Keystone and believe the Internet offers vast, diverse and unique resources to both students and staff. Our goal in providing this service to employees and students is to promote educational excellence in the school by facilitating resource sharing, innovation and communication.

With access to computers and people all over the world also comes the availability of material that may not be considered to be of educational value in the context of a school setting. On a global network it is impossible to control all materials, and an industrious user may discover controversial information. We (Keystone Education Center Charter School) firmly believe that the valuable information and interaction available on this worldwide network far outweigh the possibility that users may procure material that is not consistent with the learning outcomes of the district.

Life is a series of choices and consequences. Keystone Education Center Charter School has chosen to make Internet resources available to students, and the consequence is that they will have access to far more information than if they had to rely solely on a school library. If a student chooses to use these resources for finding information that will be of assistance in learning, the consequences will be continued access to the Internet. If a Keystone student chooses to access resources that are objectionable, adult-oriented or restricted, the consequences will be suspension or termination of access privileges. The signatures at the end of this document indicate each party who signed has read the terms and conditions and understands their significance. Failure or refusal to sign will prohibit each such person from availing themselves or their daughter/son of the use of the Internet.

Keystone Education Center Charter School teachers and administrators will deem what is inappropriate use, and their decision is subject only to confirmation by the Keystone Education Center Charter School Board of Education. The administration, faculty, and staff of Keystone Education Center Charter School may request the suspension or termination of computer use of any user who violates these acceptable use practices.
